As many of you are aware, there is considerable discussion regarding how the state of Wisconsin will survive \$5.4 billion deficits. Whereas, we are still awaiting definitive decisions by each of the state agencies, it is my understanding that there is currently a hiring freeze for any vacancies that occur. It is anticipated that this will have an impact on the Wisconsin Department of Public Instruction. One change that will occur is the inability of consultants to receive reimbursement to attend state conferences, unless they are presenting. I anticipate that by the Winter Conference in Appleton we will receive more details regarding the budget impact to WDPI.

C.A.S.E. national conference was held in November 2008. The focus of this conference was on the Response to Intervention as demonstrations of how areas districts throughout the nation are implementing this concept. There were discussions related to concerns of how the current economic dilemmas across the country will impact schools and specifically children who have special educational needs. It is clear that it is important for C.A.S.E. having strong membership and the presence in Washington DC as a new administration takes over. It was encouraging to hear from the directors from Illinois that they are optimistic about President Obama's perspective on education.

I also want to complement Phil Knobel and the other executive directors of the SAA organization for the efficient method of seeking the endorsement of all of the organization's executive boards for Tony Evers for state superintendent. The SAA organization was the first to make an endorsement for the selected position. Based on information that Phil provided to the executive board, we believe Tony will be a positive force for change and improvement. We encourage all of our members to take an active role in endorsing Tony locally as well as supporting him in whatever way you feel comfortable for the primary election in February as well as the state election in April.

The WCASS executive board will be meeting on Tuesday, February 3, 2009. If there are issues or concerns that you would like to bring to our attention, please contact any one of our executive board members prior to that time. I look forward to seeing everyone in Appleton where I predict we will likely to see more snow during our stay (smile). Until then I hope you all stay warm and safe.

# **Seclusion and Restraint Update**

As we are all aware, Disabilities Rights of Wisconsin has been actively pursuing legislation to prohibit the use of any form of seclusion and restraint in our schools. WCASS, in collaboration with several other educational organizations, opposes this type of legislation and has worked cooperatively to create a model of training for all public schools in Wisconsin. Despite these efforts, the National Disability Rights Network published an investigative report in January outlining the "horrors" caused by the use of restraint and/or seclusion. The report provides state-by-state accounts of misuse of these techniques. Recently, in a press release out of Washington D.C., Chairman Miller of the U.S. House of Representative requested an investigation into cases of abuse and neglect of school children. Below is the reprint of that article including a link to the bill H.R. 6358, Stop Child Abuse in Residential Programs for Teens Act of 2008 (H.R. 6358), which the House passed in June.

#### Chairman Miller Asks GAO to Investigate Cases of Abuse and Neglect of Schoolchildren

WASHINGTON, D.C. - U.S. Rep. George Miller (D-CA), the chairman of the House Education and Labor Committee, today asked the U.S. Government Accountability Office to further investigate recent reports of seclusion and restraint of children in public and private schools across the country. Miller's committee plans to hold a hearing on these practices in the coming months.

Earlier this month, the National Disability Rights Network released a report detailing hundreds of cases where abusive uses of seclusion and restraint by school staff injured or traumatized schoolchildren, many with disabilities. The report revealed cases where students were abusively pinned to the floor, handcuffed, locked in closets, and subjected to other acts of violence. In some of the cases, children died.

As Miller noted in his letter to GAO today, a prior GAO investigation conducted at Miller's request uncovered thousands of similar cases of abuse at teen residential treatment facilities across the country. GAO's work laid the groundwork for legislation to address these abuses, the Stop Child Abuse in Residential Programs for Teens Act of 2008 (H.R. 6358),

which the House passed in June. "Unfortunately, vulnerable children and teens are being abused all too often in other contexts," Miller wrote. "To assist in the Committee's ongoing efforts to help protect our children, I specifically request that FSI investigate the use of restraint, seclusion, and harmful aversive handling of children and youth in private and public schools."

## National Wear Red Day Friday, February 6, 2009

As perhaps many of you know, I am a heart attack survivor. Two years ago I had a heart attack while at work. Since that time, I have become an advocate for the American Heart Association as I have learned that there are many people that have no idea how prevalent heart disease is. Making informed decisions about lifestyle choices can make a difference in decreasing the often-devastating impact of this disease.

National Wear Red Day is Friday, February 6, 2009. Go Red for Women is dedicated to building awareness of heart disease among women. Heart disease is the No. 1 killer of women age 20 and over, but it is largely preventable. 1 in 3 women has some form of cardiovascular disease. More women die of cardiovascular disease than the next five causes of death combined, including all forms of cancer. However, only 1 in 5 women believes that heart disease is her greatest health threat. Research shows that women who "Go Red" are more likely to make healthy choices.
